Payment is due before cremation occurs. Acceptable forms of payment include cash, check, credit card (with a 3.5% processing fee), and insurance assignments (our fee for filing insurance assignments is \$195).

The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy an item you did not specifically ask for, we will explain the reason in writing on the statement we provide, describing the goods and services you selected.

Direct Cremation Package: **\$895**

Includes: Basic Services of Funeral Director/Direct Disposer and Staff (see below), transportation within our service area, use of climate-controlled holding facility up to 14 days, cremation/crematory fee and alternative container. (The containers we provide are rigid, covered, corrugated fiberboard containers.)

Direct Cremation without Alternative Container: **\$805**

(Container Provided by Consumer)

Includes: Basic Service of Funeral Director/ Direct Disposer and Staff, Transportation within our service area, use of climate-controlled holding facility up to 14 days, cremation/crematory fee.

Basic Services of Funeral Director/Direct Disposer and Staff: **\$395**

This charge for our basic services and overhead will be added to the total cost of the cremation arrangements you select. **This fee is already included in our charge for direct cremation.** This charge includes, but is not limited to, availability of staff 24 Hours a Day, staff and facilities to respond to initial request of services, consultation with responsible party to determine services desired, coordinating service plans with crematory and/or other parties involved in final disposition of the deceased, obtaining cremation approval from county medical examiner, and filing of local certificate.

*Embalming is not required by law; however, refrigeration is required by law in lieu of embalming and is included in your package price.

*If you want to arrange a direct cremation, which is what Citrus Grove Affordable Cremation offers, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard, cardboard, or composition materials, the container we provide are made of corrugated fiberboard. The fee for basic services and overhead is added to the total cost of the cremation arrangement you select. (The fee is included in our direct cremation package.)

***Special Consideration**

Direct Cremation where the deceased's weight is greater than 260 pounds requires a reinforced minimum alternative container, which we will provide at a cost of:

Weight: 260lbs to 300lbs:	additional \$150
Weight 300lbs to 400lbs:	additional \$350
Weight Over 400lbs:	additional \$550
